Minutes of a meeting of the Queen Thorne Parish Council held on Monday 7 September at 7.30pm by Zoom video/audio call.

Present: Cllrs McBeath, Allcard, Biddiscombe, Chick, Harris, Hayton, Lowe and DC Cllr Legg. Cllrs Dodd and Yendole were prevented from connecting to the meeting by technical issues. 2 members of the public were present.

- 2. Declarations of Interests None
- **3.** The Minutes The minutes of the meeting held on 6 July 2020 were accepted as a true record and it was agreed that they would be signed as such.

4. Business Items arising from meeting on July 6th 2020

- **a. Nether Compton Recreation Ground** As Cllr Yendole could not join the meeting this item was deferred.
- b. Primrose Lane, Mudford The barrister acting for Mudford PC has advised that a judicial review would have at least a 50% chance of success. Before any decision is taken, he will send his points to SSDC for their reaction. The Parish Council agreed to let Mudford PC know that Queen Thorne is supportive of Mudford's position, but any decision on a donation will be made at a later date once the points in the letter to SSDC are shared.
- **c. Mobile phone signal in Queen Thorne** Following news from Dorset Council that Vodafone is looking at sites to increase coverage in Dorset, the parish council agreed to ask them to consider Queen Thorne and suggest sites for infrastructure. The Clerk noted that there is no signal in Sandford Orcas, with Nether Compton patchy but signal in Trent and Over Compton is okay.
- d. Adber Triangle Wild flower seed. The Council agreed to an increased cost to around £42

5. New Business

- **a.** Planning Reform Consultation The Council agreed to individually study the consultation and make their views known to the Clerk before the October deadline. Cllr Legg stressed the major and potentially detrimental effects this could have for areas like Queen Thorne.
- **b. 29, Plot Lane, Trent** Chris Loder has agreed to discuss the consequences of recent planning decisions on this property with Dorset Council. Cllr McBeath will contact his office for a report. The council agreed that the current situation is unsatisfactory.
- **c.** Road safety on the A30 between Sherborne and Yeovil The Clerk will request information on accidents in the last 5 years from Dorset and Somerset Police.
- **d. Marl Lane:** Cllr Legg agreed to ask Highways when the resurfacing work will take place. The Clerk will make enquiries about a horse warning sign.
- e. Pot holes on Spring Lane, Sandford Orcas These will be reported to Highways
- f. Japanese Knotweed next to Homecroft, Sandford Orcas Dorset Council has now completed the spraying and will mark the area and respray in future.
- g. Funding request from Life Education Wessex for Trent School visit see below
- h. Trent School PTA funding request for Covid protection expense for Gore Farm visits
 The Council agreed to donate £600 to Trent School PTA to be divided as they see fit.
- i. New street signs in Trent Cllr Harris spoke for the whole council when he said how delighted he was that the signs have now been installed. It is thanks to the efforts and determination of Cllr Phil Street who negotiated with various bodies over many months that Trent now has street signs. The council is very grateful to Cllr Street for this and all his other service to Trent and Queen Thorne. Cllr Harris thanked Cllrs Hayton and Kipling as well as the Clerk for arranging the installation. The Council is very grateful to Ian James who worked hard to install the signs on a voluntary basis so that they might be up in time for Cllr Street's birthday. The Council agreed a gratuity of £25 to go behind the bar at the Rose and Crown for Mr James and also approved the cost of the signs at £404.01 plus postcrete at £50.70.

j. Casual Vacancy The council is very sorry that serious illness has forced the resignation of Cllr Street. Dorset Council has published a vacancy notice. This is likely to be filled by cooption at the November meeting.
